His prior history in both private and public sectors is as a facilities manager and project manager with a wide range of sizable capital projects. Since 2015 Glenn has worked as a contract project manager supporting a number of projects throughout BC's Lower Mainland, but it is his roles in project management and energy systems implementation and management that distinguish Glenn as a valuable member of Pivotal's team.

City of North Vancouver: 2003-2015. Manager of City Facilities and General Manager, Lonsdale Energy Corporation (LEC), the City of North Vancouver's district energy company.
